Reference is made to your letter dated October 20, 2005, addressed to the above referenced Taxpayer, assessing a civil penalty for transacting business in Florida prior to qualification. In reply, the following arguments are submitted:

#### A. Findings to Which Taxpayer Takes Exception:

Assessment of Civil Penalty at the Maximum allowed per year by Florida Statutes.

#### A.Laws and Facts Upon Which Taxpayer Relies:

Statement of Law: Florida Statutes code Section 607.1502(4) states that a corporation shall be liable for a civil penalty of "not less than \$500 or more than \$1,000" for each year during which it transacts business in the state of Florida without a certificate of authority.

Statement of Fact: Taxpayer concurs that a Certificate of Authority to transact business was not obtained from the Department of State for these years. However, Taxpayer maintains that the failure to obtain the Certificate was due to an Administrative over-site, and not due to willful neglect. Taxpayer also concurs that an assessment of a civil penalty is warranted, however, Taxpayer requests that the penalty be assessed at the minimum of \$500 per year rather than the maximum of \$1,000 per year. In consideration of this lesser penalty, please note that the Taxpayer did not intentionally neglect to obtain the Certificate of Authorization, but that the failure to do so was due to reasonable cause and Administrative error. Taxpayer also requests that it be taken into consideration that the corporation has duly and timely filed and paid the Corporate Income/Franchise and Emergency Excise Tax Returns with the state of Florida for the years involved.
