

We first registered to collect sales and use tax in Florida 3 years ago. Shortly after, we hired a salesman in Florida. At no time were we informed we had to register as a foreign corporation with Florida. Now, we have been informed we are required to apply as a foreign corporation to do business in the state, and that penalties and fees for 3 years have been assessed against us.

We are pleading that the accrued penalty be waived. We have been filing and submitting sales tax and employment related taxes regularly since we started doing business there in 2002. Clearly, we are not attempting to evade payment to the state. We are willing to comply with the regulations and file any other reports necessary, even paying those fees in arrears. Had we known of this requirement, we would have done it sooner.
