Thank you for your recent letter/fax requesting approval of the above-referenced name which is a Pennsylvania chartered savings bank. Your correspondence indicates Equinox Bank, FSB, located in Pembroke Pines, Florida, has just merged with and into Northwest Savings Bank. effective October 21, 2005.

Section 655.922, Florida Statutes, exempts a financial institution holding company or its subsidiaries from the prohibition of using the word "bank," "banco," "banque," "banker," "banking," "trust company," "savings and loan association," "savings bank," or "credit union," or words of similar import, in any context or in any manner in its corporate name.

Therefore, the Office will not object to the use of the above name being registered as a foreign corporation in the state of Florida.


