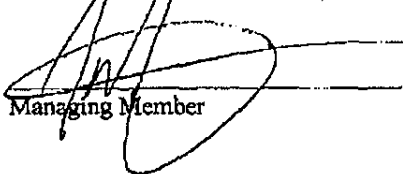

**FIRST:** The name of the Corporation is Milcom Venture Partners, Inc.

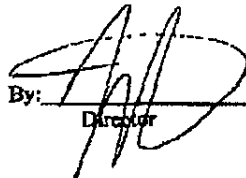
