Article III Purpose Statement: *The Foundation has been organized for the following purposes, but not limited to; Charitable, Education, Research, Christian Outreach Community Self Help Programs, Youth/ Teen Programs & Activities, Needs For Children, Disaster Relief, Christian Purpose, General. Helping those in poverty, disadvantaged, Low to middle income levels, homeless, working homeless, handicapped/ disabled, under privileged, anyone in general or special need.*

1. **Charitable:** *Housing, shelter, medical, handicap equipment, and any other special needs, necessary/ under privileged projects & programs, that help end any form of abuse, cruelty, abandonment, hungry/ starving & any other purposes legal under section 501 (A) section code 501(C) (3), 509(A) (1) & 170 (b) (1) (A) (vi). To work with other Organizations that provide services, facilities, job training, educational skills, and end of human sufferage. But not limited to. Handicap, search & rescue, companion dogs & other animals shall be trained and given away to those in need. Some animals will be used for disaster, emergencies, locating lost and missing person.*
2. **Education:** *MFM will provide full educational opportunities to all who join project by contract to MFM to complete at least 3 job skills per adult in project. Staff, employees, officers, are eligible to take all courses available. Outside individual (s) are eligible only if they qualify under our Articles & Bylaws. All adults & children involved in project must attend counseling, therapy, rehab, all Ministry courses, programs in order to complete their contract with MFM. Plus the life, extra skills & training that shall be made available. To give every advantage possible to each person. Home Christian Schooling shall be available for every child located on each site, families, employees, staff, interns, BOS and any other agents or persons working on any project site. Also available to any child who's parents can not afford to pay for it.*
3. **Research:** *MFM will do research in several areas. Basic food, hydroponic crops, higher quality yields per acre. Refertilization, reforestation, spills, landfills, soil, water. Ways to help end abuse & cruelty on all living things. Ways to find & retrieve lost, missing, abducted, runaway children & other persons.*
4. **Christian Outreach:** *To provide bibles, literature, materials, tapes & music to all in need of these items. To work with other Organizations who are providing services to the poor and needy. To promote better conditions for all children here & abroad.*
5. **Community Self Help Programs:** *Promote gardening programs public & private by citizens, families, churches, food banks, soup kitchens, jails, prisons, group & foster homes, and any other public or private organizations who can grow food & other items to give away to the community and needy. Provide emergency shelter food, medical supplies & equipment to the needy. Promote fundraising activities for civic, and charitable Organizations. Work with others to help with rent, utilities, equipment, transportation, medical needs.*
