ARTICLE II

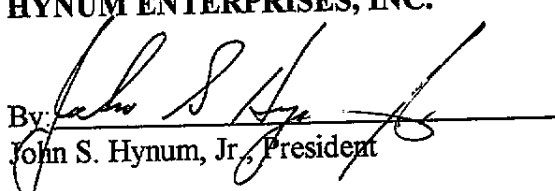
The corporation elected to dissolve by unanimous written consent of the directors and shareholders dated August 8, 1997.
