SOURCE OF FUNDS:

MLMLI will typically fund the loans from an unsecured intercompany loan from Merrill Lynch & Co., Inc., a publicly traded company on the New York Stock Exchange and its ultimate parent in the corporate structure.

MODE OF OPERATIONS -ORIGINATION, UNDERWRITING AND CLOSING:

MLMLI will originate loans through a network of in-house loan originators who will work with outside mortgage bankers and brokers and also directly with Merrill Lynch's financial client base. MLMLI's loan origination offices will be located in California, Texas and New York, with New York being the principal executive office of MLMLI. Applicant does not have any offices or any employees located in other State with respect to this business activity.

All final underwriting for the loans will be performed at applicant's New York executive office. MLMII shall use its own underwriting criteria to underwrite all loans. All loans shall be approved by applicant's credit committee located in New York.

The loans will be funded and closed from MLMLI's New York office. The loans will be closed in escrow through arrangements made with a national licensed title insurance company. All loans will be originated and closed in MLMLI's own name. MLMLI will be named as the lender/beneficiary on the note, deed of trust and other loan documents.

Initially, the staff of MLMLI will consist of 30 professionals from wide, dedicated to originating, purchasing, underwriting, closing and preparing loans for inclusion in bond offerings,

OTHER MISCELLANEOUS COMMERCIAL MORTGAGE ACTIVITIES:

MLMLI is licensed as a Title II Nonsupervised Mortgagee approved by the United States Department of Housing and Urban Development to originate and service mortgage loans. Pursuant to such authority, MLMLI acts as the master servicer of record for 19 FHA-insured multifamily health care facilities' mortgage loans with an unpaid principal balance as at Deember 31, 2001 of approximately \$605 million. These loans are actually sub-serviced by a licensed subservicer. MLMLI only actual obligation is to collect the servicing fees and monitor performance by the subservicer.
