Thank you for your recent letter/fax requesting approval of the above-referenced name which is a state-chartered financial institution located in Colquitt, Georgia and a wholly-owned subsidiary of PeoplesSouth Bancshares, Inc. The Bank also has offices located in Malone, Greenwood, Marianna, and Chipley, Florida, due to the merger of PCB, The Community Bank, (Malone) with and into PeoplesSouth Bank, effective April 2005.

Section 655.922, Florida Statutes, exempts a financial institution holding company or its subsidiaries from the prohibition of using the word "bank," "banco," "banque," "banker," "banking," "trust company," "savings and loan association," "savings bank," or "credit union," or words of similar import, in any context or in any manner in its corporate name.

Therefore, the Office will not object to the use of the above name being registered as a foreign corporation in the state of Florida.
