

Ladies and Gentlemen:

Northwestern Mutual Wealth Management Company (f/k/a Northwestern Mutual Trust Company) (the "Company"), Milwaukee, Wisconsin, is a federal trust-only savings bank organized under the authority of the Home Owners' Loan Act (12 U.S.C. § 1461, et seq.), and a federally-registered investment adviser under the terms of the Investment Advisers Act of 1940. The Company's primary regulator is the Office of Thrift Supervision ("OTS"), an agency of the U.S. Department of Treasury. Not unlike other federal banking regulators, the OTS has consistently held that state laws attempting to limit or condition the powers granted to federal savings banks are preempted. States authorities, however, retain the right to require a federal savings bank transacting business in the state to file a certificate of authority with the state and appoint a registered agent. It is expected that the Company will begin transacting business in Florida no sooner than January 31, 2006.

Enclosed for filing on behalf of the Company are the original and one copy of the signed Transmittal Letter and the Application by Foreign Corporation for Authorization to Transact Business in Florida. To cover the cost of filing fees for the Company, I have enclosed the Company's check in the amount of \$70.00 made payable to the Florida Department of State. Also enclosed please find an original Certificate of Corporate Existence issued by the OTS.
