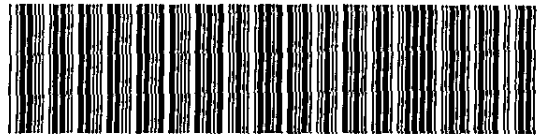



WE THE UNDERSIGNED ALL BEING PERSONS OF FULL AGE, EIGHTEEN YEARS OF AGE OR OVER, FOR THE PURPOSE OF INCORPORATING AN UNINCORPORATED NON-DENOMINATIONAL ORGANIZATION PURSUANT TO ARTICLE 10 OF THE RELIGIOUS CORPORATIONS LAW, DO HEREBY CERTIFY AS FOLLOWS:

1.
