

Enclosed please find your notice dated October 27, 2005, assessing \$5,750 worth of penalties on the above referenced taxpayer for failure to qualify to do business in the State of Florida. We respectfully request abatement of said penalty. Though the corporation did fail to qualify it did so out of not understanding the laws of Florida and there was no intentional disregard of the law. Additionally, the income allocated to the State of Florida is only a couple of thousand dollars a year. I noticed that you have levied the maximum civil penalty of \$1,000 for this failure.
