Enclosed please find a copy of your letter dated December 29, 2005 together with my Corporation's Certificate of Existence from New York State.

I am writing to formally request that the \$6,900.00 in penalty fees relating to non-registration be abated in their entirety, for the following reasons.

Cobble Hill Center Corp was incorporated in New York State on December 23, 1966. In December of 2000 the Corporation acquired two one-room "condo-hotel" units in Miami Beach. Florida. At that time I had local legal representation to assist in the transfer of title, with me mention of the fact that we had to register with the State of Florida as a Foreign Corporation.

In addition, my accountant informs me that as soon as we began doing business in Florida he went to the Florida state website and obtained all of the instructions for meeting tax requirements in Florida. He assures me that there was no mention at all of a requirement to register with the State. Importantly, since doing business in Florida, all Corporate Forms 1120F have been filed on time. My accountant and I believed we were doing everything required of us to meet all Florida requirements. I would add that we were never notified by the State of the requirement to register even after making timely filings of Form 1120F for a number of years. We would certainly have done so as soon as we became aware of the requirement.

For these reasons I respectfully request that all penalty fees relating to non-registration be

waived.
