Thank you for your recent letter/fax requesting approval of the above-referenced name which is the holding company for Citizens First Savings Bank, located in Port Huron, Michigan.

Section 655.922, Florida Statutes, exempts a financial institution holding company or its subsidiaries from the prohibition of using the word "bank," "banco," "banque," "banker," "banking," "trust company," "savings and loan association," "savings bank," or "credit union," or words of similar import, in any context or in any manner in its corporate name.

Therefore, the Office will not object to the use of the above name being registered as a foreign corporation in the state of Florida.

However, this does not authorize the institution to engage in a banking business in the state of Florida and this does not give one the authority to act in any licensed capacity until all licensing requirements have been met within this state. Proper regulatory approvals will be required.
