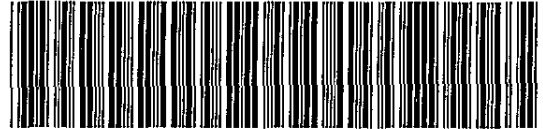

Dear Karen Beyer:

This is a request for special consideration regarding the penalty fees that have been assessed on my application for authority to transact business in Florida. They're an extreme hardship.

I have a one person consulting business that I have operated out of my home for over 27 years. Since 2000 the revenues generated by the business each year have varied from \$ 29,600 to \$ 60,600 and have averaged \$ 43,880. After expenses that would not be considered a very large business and I haven't even made a profit for the last several years. This year I have only generated \$ 2,900 in revenue to date and am thinking seriously of backing off completely and not trying to produce any new business. I'll be 71 this summer.

Over the years, I've worked with 380 companies and 26 of them have been Florida companies. Of the latter, only 4 concerned assignments that were delivered since 2000. Typically the recent Florida projects involved 1 to 4 days and were not repeated. It could be argued that I would be exempt, per 607.1501 (2j): conducting an isolated transaction that is completed within 30 days and that is not one in the course of repeated transactions of a like nature. However, I wanted to be fair and hoped I might be doing more longer-term consulting in Florida, so I continued with the application.

My son (who lives in Missouri) incorporated the business for me in 2001. We thought we were going to develop and sell a computer-training program for teleselling, but nothing ever came of it. Since we had filed as a corporation during those years, it seemed easier to continue with it.

I was just trying to do the right thing and definitely not expecting such an onerous cost - I thought it might be several hundred dollars. Can it be reduced to such an amount or is it possible that I am legitimately not transacting business in Florida and should file again?





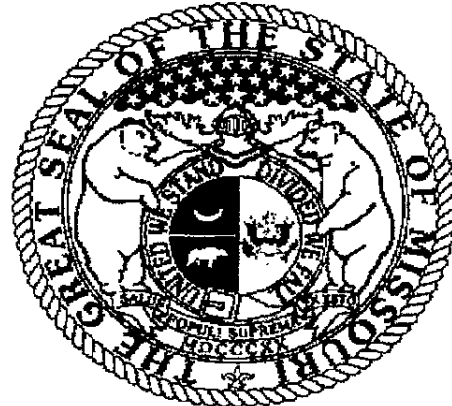
