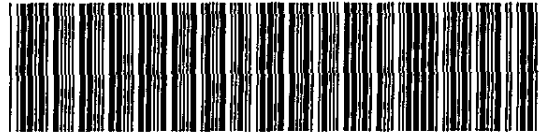

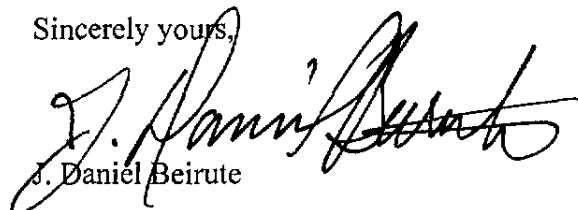

WHEREAS, the corporation's legal name, New Life International, Inc., is already in use by another corporation in the State of Florida; and

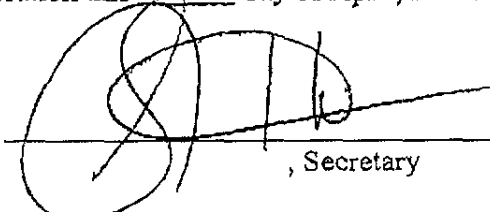
