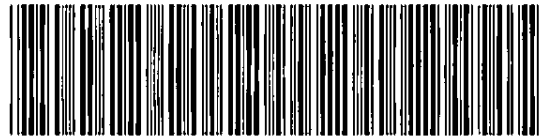

ARTICLES OF DOMESTICATION OF  
Intercom Federal Systems Corporation

The undersigned, on behalf of the foreign corporation set forth below, pursuant to Title 13.1, Chapter 9, Article 12.1 of the Code of Virginia, states as follows:

1. The name of the corporation immediately prior to the filing of these articles of domestication is INTERCOM FEDERAL SYSTEMS CORPORATION. Upon the filing of these articles, the name of the corporation shall be INTERCOM FEDERAL SYSTEMS CORPORATION.
2. The corporation was originally incorporated under the laws of Maryland on 08/03/1992.
3. The plan of domestication, pursuant to § 13.1-722.2 of the Code of Virginia, is set forth as follows:
  - A. The corporation is presently domesticated in the Maryland.
  - B. The jurisdiction in which the corporation is to be domesticated is the Commonwealth of Virginia.
  - C. Intercom Federal Systems Corporation, a Maryland corporation (the "Company"), was originally formed on August 3, 1992 and is presently domesticated under the laws of the State of Maryland.

The Company is to be domesticated under the laws of the Commonwealth of Virginia.

At the Effective Time (defined below), (a) the Company shall, by virtue of the domestication, become a Virginia corporation and cease to be a Maryland corporation, (b) the name of the Company shall be Intercom Federal Systems Corporation, and (c) the ownership proportion and relative rights, preferences, and limitations of the interests of the Company shall not be altered in any way.

The effective date and time of the domestication shall be August 11 2017 at 12:01 a.m., Eastern Time (the "Effective Time").

The foregoing Plan of Domestication is permitted under, and shall be effectuated in accordance with, the laws of the Commonwealth of Virginia and the laws of the State of Maryland.

The Company's stockholder may amend this plan of domestication at any time prior to the effective date of the certificate of conversion and certificate of formation filed with the Maryland Secretary of State to consummate the domestication.

4. The full text of the articles of incorporation that will be in effect immediately after consummation of the domestication is attached hereto.
5. The domestication is permitted by the laws of the jurisdiction in which the corporation is incorporated immediately prior to the filing of these articles, and the corporation has complied with those laws in effecting the domestication.

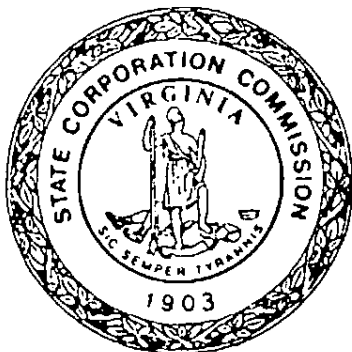
