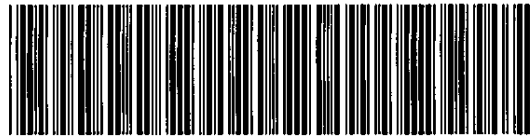

SUBJECT: Your Request for Clarification of Our Request for Florida Tax Exemption

Dear Ms. Cushing:

This will attempt to clarify information in our cover letter and our Application By Foreign Not For Profit Corporation for Authorization to Conduct its Affairs in Florida.

The Sunshine Region (SSR) is part of International Training in Communication (ITC), (formerly Toastmistress Clubs), with men and women members from Florida, Georgia, Alabama, Mississippi, Louisiana and Bahamas. Our annual SSR training conferences rotate among these six locations, and the Clarion Westshore Hotel, Tampa, Florida is the site of our 18-21 May, 2006 Conference. The Clarion requires a Certificate in order for ITC to qualify for exemption. Mrs. Janice Mitchell Isbell, President of SSR, (of Huntsville, AL) has tasked me to secure the Tax Exempt Certificate from the State of Florida.

ITC incorporated in the State of California on 25 June 1938. Since incorporating, clubs have formed world wide, many in Florida. My club membership is Miracle Strip Communicators of Fort Walton Beach, FL, founded in 1974, which is why I use this as when we first began conducting affairs. The founding dates of many clubs, active and inactive, in Florida are unknown to me, and would be hard to determine – since over the years clubs have been discontinued and new ones are being planned.

I believe that Florida ITC clubs never applied for a Certificate, because the idea of tax relief was never considered. At our Conference in Mississippi, the hotel accepted our IRS letter as proof of non-profit status. However, when the need for a Certificate in Florida became known and the process was started.

ITC is exclusively an education, non-profit organization. All funds raised go to provide education, training and seminars, plus charitable efforts; our current charity is the SSR ITC Hurricane Relief Fund for Gulf Coast ITC members, and help with rebuilding a community center for Biloxi, Mississippi.

We appreciate the extra effort made by all those persons involved in the venture to expedite our request. My husband and I will drive through Tallahassee on our way to Tampa on Tuesday, May 16. We will stop by your office at The Clifton Building to thank you and your staff, and to accept the Certificate.


Our records indicate that your organization is also classified as a public charity under section 509(a)(2) of the Internal Revenue Code.
