Currently we are listed as "Heartbeat of Miami, Inc." because we couldn't use "Heartbeat International" in Florida. We would like to change "Heartbeat of Miami, Inc." to "Heartbeat of Florida, Inc." The standard form to file an "Amendment to Application for Authorization to Transact Business in Florida" does not quite fit our scenario because question four assumes that we have changed our name for purposes of the State of Incorporation (Ohio). This is not the case. We remain incorporated under the name "Heartbeat International, Inc." in Ohio.
