In the past, Tamanet believed, to the best of its knowledge and understanding, that it was not required to qualify in the State of Florida.

EXEMPT: Tamanet's belief was based on the following facts: - Company (Annual Company Co

1. Tamanet has no offices or employees in Florida.

When Tamanet sends goods through interstate commerce to customers within the State of Florida, this is always done by common carriers, not by vehicles owned or operated by Tamanet.

(27) 3. All orders to Tamanet from Florida customers are subject to acceptance by Tamanet's home office in Fullerton, California, as evidenced by the attached copy of Tamanet's

Terms and Conditions of Sale.

4. Goods sold by Tamanet are sometimes stored in a public warehouse within the State of Florida pending delivery. However, Tamanet does not itself operate any warehouse within the State, and avails itself of storage services only as an adjunct of owning personal property within the State.

Moreover, as soon as Tamanet understood that it was required to qualify in states other than California, Tamanet took the necessary steps to qualify, such as in the state of Georgia where Tamanet does maintain an office and an employee.

Thus, Tamanet's course of action was taken in good faith and without intent to avoid any obligation imposed by any state law or regulation.

We therefore respectfully request that the Division refund us the full amount of Tamanet's erroneous payment, or alternatively in consideration of the overall circumstances, reverse the State's imposition of civil penalties and refund the payment, either in its entirety or in part.
