I am writing on behalf of Bailey Farms, Inc., a Michigan corporation, in response to your letter of May 25, 2004, and the rejection of the application by foreign corporation for authorization to transact business in Florida.

As indicated in your letter of May 25, 2004, you proposed to assess the maximum statutory penalty of \$1,000 per year for the transaction of business in the state of Florida. Under the circumstances, while not presently conceding the need to register as a foreign corporation, we request that you reduce the proposed penalty to the statutory minimum of \$500 per year.

The primary activity of Bailey Farms, Inc., has been the actual ownership and lease of property which, of itself, would not require authorization. The corporation has, in addition, engaged in some farm-related activities. The principal of that corporation was previously under the impression that he did not need to register a foreign corporation in order to own or operate a farm. Without conceding the need for registration, any oversight was entirely unintentional.




