Thank you for being so helpful in our phone conversation yesterday, 6/6/06. I spoke with Diane from your office later in the day and she helped me to understand the Florida statute 607.1501 that governs the definition of "transacting business" in Florida. Based upon this statute, our activity in Florida does not constitute "transacting business". I have spelled this out below:

- 1. Our main activity in Florida is selling through independent distributors. This is exempted in section 607.1501 (2) (e).
- 2. We have one customer that we sell product directly to them from our Ohio warehouse. This would constitute simple interstate commerce and is exempted in section 607.1501 (2) (i). We collect sales taxes on this direct sale and submit these sales taxes to the State of Florida.

Based upon these facts and the applicable statutes, our activities do not constitute "transacting business" in the State of Florida. We would still like to obtain a Certificate of Authority from the Department of State. We have corrected our original submission and included it in this mailing. I believe that you kept our original check for \$87.50 as payment for the filing fee and provides us with a Certificate of Status and a Certified Copy.
