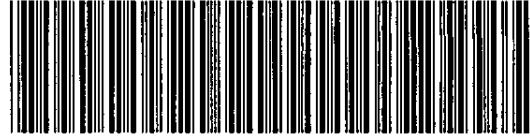





ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION OF
STREETROD PRODUCTIONS, INC.

TO THE SECRETARY OF STATE OF THE STATE OF IOWA:

Pursuant to Sections 490.1003 and 490.1006 of the Iowa Business Corporation Act, as amended (the "Act"), the undersigned corporation (the "Corporation") hereby adopts the following amendment to the Corporation's Articles of Incorporation:

I. Name of Corporation. The name of the corporation is STREETROD PRODUCTIONS, INC.

II. Amendment to Articles of Incorporation.

a. Article I of the Corporation's Articles of Incorporation is hereby deleted and replaced with the following:

The name of the corporation shall be SRP Villages, Inc.

III. Date of Adoption. The amendment was adopted by the Corporation's Directors on July 10, 2015, and by the Shareholders on July 10, 2015 to be effective upon the filing with the Secretary of State.
