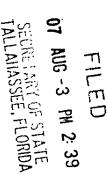

For the purpose of amending the Articles of Incorporation of BLACK, CORLEY & OWENS, P.A., an Arkansas professional association (the "Corporation") under the Arkansas Professional Corporation Act, as amended (Act No. 576 of 1965 and Act No. 155 of 1963), the Corporation does hereby amend said Articles of Incorporation as follows:

1. Article FIRST of the Articles of Incorporation shall be amended to be effective as of January 1, 2006, to read as follows:
