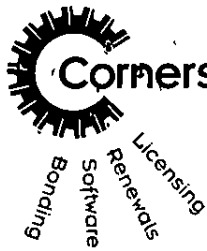



This document has been approved in the manner required by the Texas Business Organizations Code and by the governing documents of the Entity.


