I am writing in response to the attached notice dated June 9, 2006. The notice informed us that we owe \$2,000 in penalties for conducting business in Florida prior to qualification.

We are a small business with only a couple of people in our office. We were called by Florida Power & Light on an emergency basis to help with the clean up after the humicanes in 2004. During 2005, we were called back to Pensacola to help that city get its power back on. We then got called while still working in Florida to also help Louisiana power companies reestablish power and clean up after Humicane Katrina.

At the time that we began doing business in the state of Florida, we were unaware that we were required to register with the Florida Department of State and we believed that all necessary registrations had been filed. When we became aware of the filing requirement, we immediately filed our registration. We respectfully request that you abate the penalty.
