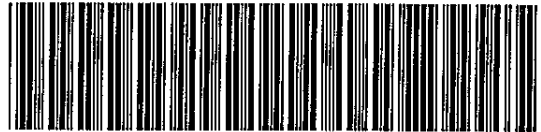



1. The following provisions of the Articles of Incorporation of Rental Man, Inc., filed in Tallahassee on November 20, 1980 and they are hereby amended as follows:
