ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF HELEN W. ADELMAN, C.P.A., P.A.

The undersigned, sole shareholder of the Florida corporation named above, hereby files this certificate of Articles of Amendment to the Articles of Incorporation of said corporation:

- A. The name of the corporation is Helen W. Adelman, C.P.A., I
- B. The text of the one amendment adopted is as follows:

Article III of the Articles of Incorporation is amended to read as follows:

"Article III"

"The purpose or purposes for which this corporation is organized and the general nature of the business to be transacted by this corporation are the investment of company funds in real estate, mortgages, stocks, bonds or any other type of investments and the owning or leasing of real or personal property necessary for such, but this corporation shall no longer transact the practice of public accounting."

- C. This amendment does not provide for any exchange, reclassification or cancellation of issued shares.
- D. This amendment was adopted December 1, 2000.
- E. This amendment was not adopted without shareholder action.
- F. This amendment was approved by the sole holder of all of the shares of common stock of the corporation, by written consent given in accordance with Section 607.0704 Florida Statutes, and the number of votes cast for the amendment by the sole voting group was sufficient for approval by that voting group.
