Re: Application for Authority to Indirectly Acquire a Controlling Interest in The Bank Brevard, Melbourne, Brevard County, Florida (Bank), by The BANKshares, Inc., John Eggemeyer, Mark Merlo, William Ruh, Castle Creek Capital Partners III LP, Castle Creek Capital III LLC, Eggemeyer Capital LLC, Ruh Capital LLC and Legions IV Advisory Group (Applicants) Administrative File No. 0359-B-11/06)

I, Linda B. Charity, Director of the Division of Financial Institutions, Office of Financial Regulation (Office), have considered the information presented in the application for Authority to Acquire a Controlling Interest in The Bank Brevard (Bank) by the Applicants. I give notice that I intend to approve the application and make the following:

FINDINGS OF FACT

- (1) The application was filed with the Office on September 8, 2006.
- (2) Notice of the application was published in the Florida Administrative Weekly on September 22, 2006. No request for a hearing was made and none was held.
- (3) The application was deemed substantially complete as of October 17, 2006, resulting in a decision due date of January 15, 2007.
- (4) Applications were approved by the Federal Reserve Bank of San Francisco on September 29, 2006, for The BANKshares, Inc. (Holdings): Rancho Sante Fc. California, to become a bank holding company by acquiring 100 percent of THE BANKshares; Inc., Melbourne, Florida; and indirectly the Bank pursuant to Section 3(a)(1) of the Bank Holding Company Act; and for the Applicants and Holdings to acquire 100 percent of THE BANKshares, Inc., pursuant to Section 3(a)(3) of the Bank Holding Company Act.
- (5) The Bank is a state-chartered bank with its main office located at 300 South Harbor City Boulevard, Melbourne, Brevard County, Florida. It is authorized to operate two branch offices in Florida. The Bank is a wholly owned subsidiary of THE BANKshares, Inc., a Florida bank.holding.company registered under the Bank Holding Company Act, headquartered in Melbourne, Florida. The Bank has been in existence and operating for more than three years.
