





Exodus is a Christian-faith based organization with a primary goal of supporting individuals recovering from substance abuse so that they may become productive members of the society in which they live. To accomplish this goal Exodus will conduct a preventative program for drug and alcohol addiction based on the Christian faith and study of the Bible.
