



CERTIFICATE OF FORMATION

of

THE GEORGE W. BUSH PRESIDENTIAL LIBRARY FOUNDATION

I, the undersigned natural person, being of the age of eighteen years or more and a citizen of the State of Texas, acting as organizer of a corporation under the Texas Business Organizations Code, do hereby adopt the following Certificate of Formation for such corporation:

ARTICLE ONE

The name of the entity is THE GEORGE W. BUSH PRESIDENTIAL LIBRARY FOUNDATION (hereinafter referred to as the "Corporation").

ARTICLE TWO

The filing entity being formed is a non-profit corporation.

ARTICLE THREE

The period of the Corporation's duration is perpetual.

ARTICLE FOUR

The purposes for which the Corporation is organized arc to (i) endow a Presidential archival depository, as defined by Section 2101(1) of Title 44 of the United States Code Annotated, in an amount required by subsection (g) of Section 2112 of Title 44 of the United States Code Annotated, to house and preserve the books, documents, papers, pictures, photographs and other memorabilia of President George W. Bush, as well as other objects or materials related to the papers or events of the official or personal life of President Bush that have historical or commemorative value, and to undertake and support research and educational activities on policy and historical issues related to the life and work of President Bush, (ii) maintain a fund or funds of real or personal property, or both, and (subject to the restrictions and limitations hereinafter set forth) to distribute the whole or any part of the income or principal thereof exclusively for charitable, religious, scientific, literary or educational purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended and (iii) to engage in any lawful activity for which non-profit corporations may be organized under the laws of the State of Texas. The Corporation pledges all of its assets for use in performing these purposes.

ARTICLE FIVE

The Corporation shall have no members, its governing body being its Board of Directors.

ARTICLE SIX

No part of the net earnings of the Corporation shall inure to the benefit of any director of the Corporation, officer of the Corporation, or any private shareholder or individual, and no director or officer of the Corporation, or any private shareholder or individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publication or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provisions of this Certificate of Formation, the Corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by any organization exempt from taxation under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended.

ARTICLE SEVEN

Notwithstanding the provisions of sections 22.304(a) (2) and 22.304(b) of the Texas Business Organizations Code, upon the liquidation, dissolution or winding-up of the Corporation (whether voluntary, involuntary or by operation of law), the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the Corporation, dispose of all of the assets of the Corporation exclusively for the purposes of the Corporation, or to such organization or organizations organized and operated exclusively for charitable, religious, scientific, literary or educational purposes as shall at the time qualify as an exempt organization or as exempt

organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, in such manner as the Board of Directors shall determine.

ARTICLE EIGHT

The internal affairs of the Corporation shall be regulated by the Bylaws to be adopted by the Board of Directors. The Board of Directors shall have the power to alter, amend, or repeal the Bylaws or to adopt new Bylaws as provided therein.

ARTICLE NINE

The address of the initial registered office of the Corporation is 600 Travis, Suite 4200, Houston, Texas 77002, and the name of its initial registered agent at such address is Terri Lacy.

ARTICLE TEN

The number of directors constituting the initial Board of Directors is three (3), and the names and addresses of the persons who are to serve as the initial directors are as follows:
