# Application by Foreign Corporation for Authorization to Transact Business in Florida

#### US Fidelis Administration Services, Inc.

8. Purpose(s) of the corporation authorized in home state or country to be carried out in Florida:

1. To engage in providing and administrating service contracts and to do all things necessary to carry out this purpose, 2. To acquire, own, hold, lease, rent, trade, and generally deal in property, real, personal, or mixed, tangible or intangible, of every kind and description and wherever located; to provide and supply services and products by use of machines, equipment, devices, or personnel; to transport and store any property or equipments, and to do and perform all things incident to such intended purpose. 3. To purchase, lease, take in exchange, or otherwise acquire lands or interests therein, together with any buildings or structures that may be on said lands, or any of them, and to sell, lease, exchange, or otherwise dispose of the whole or any portion of the lands, and any or all of the buildings or structures that are now or hereafter may be erected thereon, and to take such security therefore as may be deemed necessary; to erect buildings and deal in building materials; to take or hold mortgages for any unpaid balance on the purchase money on any of the lands, buildings, or structures so sold, and to sell or otherwise dispose of said mortgages; to improve, alter, and manage the said lands and buildings; to guarantee and otherwise assist in the performance of contracts or mortgages or persons, firms, or corporations with whom the Corporation may have dealings; and to assume and take over such mortgages or contacts on default. 4. To acquire by purchase, subscriptions, or otherwise and to own, hold, sell, negotiate, assign, deal in, exchange, transfer, mortgage, pledge, or otherwise dispose of any shares of the capital stock, scrip, or voting trust certificates in respect of the shares of the capital stock of, or any bonds, mortgages, securities, or evidences of indebtedness issued or created by any other corporation, joint stock company, or association, public or private, or in the government of the United States of America or of any foreign government, or any state, territory, municipality, or other political subdivision, or any, governmental agency; and to issue in exchange therefore in the manner permitted by law, shares of the capital stock, scrip, voting trust certificates, bonds, mortgages, or other securities or evidences of indebtedness, to possess and exercise in respect thereof any and all rights, powers, privileges of ownership, including the right to vote thereon. 5. To acquire the good will, rights, assets, and any property of any person, firm, association, or corporation and to pay for the same by eash, property, or services, and in connection therewith to assume or undertake the whole or any part of the obligations or liabilities of such person, firm, association, or organization. 6. To take part in the management, supervision, or control of the business or operation of any company or undertaking, and for that purpose to appoint and remunerate any directors, accountants, or other experts or agent. 7. To acquire, hold, use, sell, assign, lease, grant licenses in respect of, mortgage or otherwise dispose of letters of patent of the United States or any foreign country, patent rights, licenses or privileges, inventions, improvements and processes, copyrights, trademarks, and trade names, relating to or useful in connection with any business of this Corporation. 8. To purchase, hold sell, and transfer the shares of its own capital stock under any limitations imposed by law, provided that shares of its own capital stock belonging to it directly or indirectly shall not be voted upon or be eligible to receive dividends from the Corporation. 9. To borrow or raise moneys for any of the purposes of the Corporation, or for the purpose of advancing said moneys to other corporations or businesses and from time to time, without limit as to amount, to draw, make and accept, endorse, execute and issue promissory notes, drafts, bills of exchange, warrants, bonds, debentures, and other negotiable or non-negotiable instruments and evidences of indebtedness, and to secure the payment of any thereof and of the interest thereon by mortgage upon or by pledge, conveyance, or assignment in trust of the whole or any part of the property of the Corporation whether at the time owned or thereafter acquired, and to sell, pledge, or otherwise dispose of such bonds or other obligations of the Corporation. 10. To buy, sell, or otherwise deal in notes, open accounts, and other similar evidences of debts, and to loan money and take notes, open accounts, and other similar evidences of debt as collateral security therefore. 11. To furnish to others, whether or not incorporated, business supervisory and management services and advice. 12. To enter into, make and perform contracts of every kind and description with any person, firm, association, corporation, or municipality, state, county body politic, or government or colony or dependency thereof. 13. To have one or more offices, to carry on any or

all of its operations and business, and without restriction or limit as to amount to purchase or otherwise acquire, hold, own, mortgage, sell, lease, convey, or otherwise dispose of real and personal property of every class and description in any of the states, territories, districts, or colonies of the United States, or any and all foreign countries, subject to the laws of such state, district, territory, colony, or country. 14. In general to carry on any other business in connection with the foregoing, on its own account, or for others, and to have and exercise all the powers conferred by the laws of Missouri, and to do any and all other things herein before set forth to the same extent as natural persons may or could do. The foregoing clauses shall be construed both as objects and powers, and it is hereby expressly provided that any enumeration of specific powers herein before made shall not limit or restrict in any manner any general powers herein before expressed or permitted by law, nor shall the Corporation be required to exercise all of said powers at any one time.
