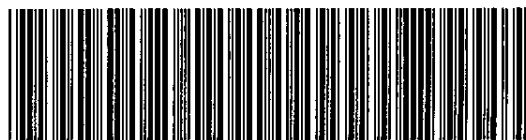


Dear Ms. Wolf,
