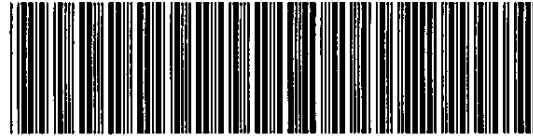

The principal of this entity is a Spanish Citizen and, as such, he had difficulty obtaining a Federal Employers Identification Number from the Internal Revenue Service due to his visitor status and due to the elaborate application process which he did not understand. He was under the mistaken understanding that he could not file with the State until such time as he had a FEIN number. Immediately upon receipt of the FEIN number, December 11, 2006, he filed for his State of Florida registration.

Please consider relief of the penalties and we will be happy to pay the fees for the prior year annual reports.

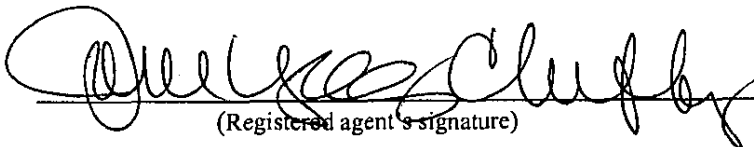

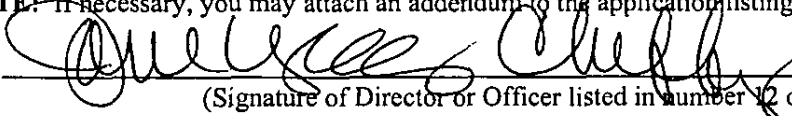
