

## Power of Attorney



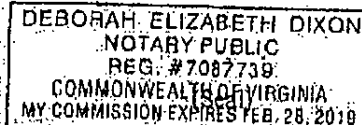
