Dear Ms. Cushing,

I am the owner of Classic Motorworks in Faribault MN. We are the US Distributor of the Royal Enfield motorcycle. In June of 1999 we applied for a license as a motorcycle distributor with the Florida Division of Motor Vehicles. We were issued a license and have re-newed that license every year since then. We have had extensive contact with the Florida Division of Motor Vehicles regarding the license over the years to make certain that we were doing every thing properly.

We were recently contacted by your office and told that we needed to be registered in the State of Florida as a corporation in order to continue to do business. This was new information to us, but nonetheless we complied immediately and are now ready to finish that process. As we were checking our application with Ms. McKnight she informed us that we would be liable for a penalty of \$1,000 for every year that we were unlicensed.

We are a small company and this is an overwhelming amount of money for us. I am respectfully asking you to consider waiving our penalty based on our effort to comply over the course of several years. We had no way of knowing that more was required of us as a licensed distributor. When we were issued our license to do business as a distributor in Florida and through the subsequent renewals we naturally assumed that when the state issues us a license that we had fully complied with Florida law. None of the applications or contact with people from the Division of Motor Vehicles indicated that more was required. We are licensed and registered in some other states, but normally those that require a registration, make it a requirement of granting a distributor license. I realize that ignorance of the law is no excuse but I would ask for a waiver based on our unblemished record of trying to comply with Florida law and doing everything we could to be good corporate citizens.

Thank you for your time and consideration as well as your prompt attention so we do not lose our license.


