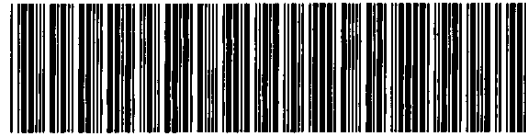

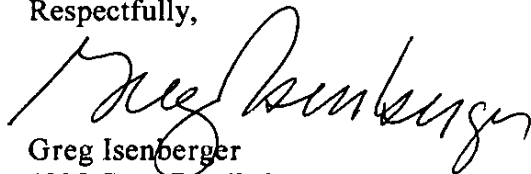
Dear Becky,

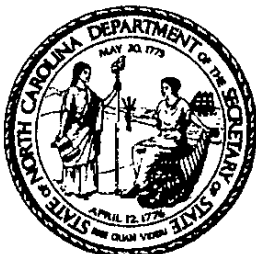
