6. The Corporation acquired the Administrative Professionals Conference, a national event held each year at a different location around the country, in 2006. At the time, it was not clear that the 3-day conference, which was then scheduled to be held in Orlando beginning October 15, 2006, would be anything but an isolated, one-time transaction by the Corporation in Florida. Accordingly, it was determined, under Fla. Stat. ch. 607.1501(j), that the Corporation was not required to obtain authority to transact business in Florida. Because the Corporation now anticipates holding additional events in Florida, it believes that it now is required to file an Application for Authorization. The Corporation respectfully requests, on the basis of the foregoing information, that the State of Florida decline to impose any penalties which otherwise might apply in this situation.
