TRANSFER OF SHARES

1. Transfer

The shares or debentures of a Company may be transferred by a written instrument of transfer signed by the transferor and naming the transferee.

- 2. Any share of the company may not be transferred before the pre-emptive rights described in the following paragraphs have been exhausted. Any share of a deceased member may be transferred by his personal representative to any child or other issue of such deceased member and shares standing in the names of the trustees of the will of any deceased member may be transferred upon any change of trustees to the trustees for the time being of such will but save as aforesaid and save as provided by paragraph 7 thereof no share shall be transferred to a person who is not a member so long as any member or any person selected by the Directors as one whom it is desirable in the interests of the Company to admit to membership is willing to purchase the same at the fair value.
 - 2.1 In the event that the child or other issue of the deceased member is under the age of 21 years, the directors for the time being, shall hold the shares in trust for the child or other issue and shall have power to vote and all other rights of ownership except that they shall receive dividends for and on behalf of the beneficial owners and shall hold such dividends solely on their behalf and shall administer and apply such funds for the benefit of the beneficiaries as the directors shall in their discretion consider appropriate from time to time.
 - 2.2 Notwithstanding the provisions of paragraph 2, a share may be transferred by a member to any spouse or child or remoter issue of that member, and the pre-emptions hereinbefore conferred shall not arise on the occasion of any such transfer.
- 3. The person proposing to transfer any share (hereinafter called "the proposing transferor") shall give notice in writing (hereinafter called a "transfer notice") to the Company that he desires to transfer the same. Such notice shall specify the sum he fixed as the fair value, and shall constitute the Company his agent for the sale of the share to any member of the Company or person selected as aforesaid willing to purchase the share (hereinafter called "the purchasing member") at the price so fixed, or, at the option of the purchasing member, at the fair value to be fixed by the valuator in accordance with paragraph 5 hereof. A transfer notice may include several shares, and in such case shall operate as if it were a separate notice in respect of each. A transfer notice shall not be revocable except with the sanction of the directors.
- 4. If the Company, within the space of ninety days after being served with a transfer notice, finds a purchasing member, it shall give notice thereof to the proposing transferor, and he shall be bound, upon payment of the fair value as fixed in accordance with paragraphs 3 or 5 hereof, to transfer the share to the purchasing member.

- In case any difference arises between the proposing transferor and a purchasing member as to the fair value of a share, either party may request of the directors the General Manager for the time being of the Trinidad and Tobago Stock Exchange be requested to appoint a valuator and the valuator shall, certify in writing the sum which, in his opinion, is the fair value, and such sum shall be deemed to be the fair value, and in so certifying the valuator shall be considered to be acting as an expert, and not as an arbitrator; and accordingly the Arbitration Ordinance shall not apply.
 - 5.1 In the event that the valuator has been requested to certify his opinion of the fair value of the shares to be transferred the time period imposed by paragraphs 4 and 7 shall not be deemed to begin until the valuators' certified opinion is received by the company.
- 6. If in any case the proposing transferor after having become bound as aforesaid, makes default in transferring the share, the Company may receive the purchase-money, and the proposing transferor shall be deemed to have appointed any one Director or the Secretary of the company as his agent to execute a transfer of the shares to the purchasing member and upon the execution of such transfer the company shall hold the purchase-money in trust for the proposing transferor. The receipt of the company for the purchase-money shall be a good discharge to the purchasing member, and after his name has been entered in the register in purported exercise of the aforesaid power, the validity of the proceedings shall not be questioned by any person.
- 7. If the Company shall not, within the space of ninety days after being served with a transfer notice, find a purchasing member and give notice in manner aforesaid, the proposing transferor shall at any time within thirty days afterwards be at liberty, subject to paragraph 9 hereof, to sell and transfer the share (or where there are more shares than one of those not placed) to any person and at any price but not less than the price fixed in the transfer notice either on the fair value as determined herein.
- 8. The shares comprised in any transfer notice shall be offered in the first place to the members, other than the proposing transferor, as nearly as may be in proportion **Reflecteding** shares field by them, respectively, and the offer shall in each case limit the time within which the same, if not accepted, will be deemed to be declined, and may notify the members that any member who desires an allotment of shares in excess of his proportion should in his reply state how many excess shares he desires to have; and if all the members do not claim their proportions the unclaimed shares shall be used for satisfying the claims in excess. If any shares shall not be capable, without fractions, of being offered to the members in proportion to their existing holdings, the same shall be offered to the members or some of them, in such proportions or in such manner as may be determined by lots to be drawn under the direction of the Directors. And in each case the member to whom the offer is made shall have the option of buying at the price fixed in the transfer notice or, at his option, at the fair value, to be fixed by the valuator as aforesaid such option to be declared in accepting the offer.
- The Directors may in their absolute and uncontrolled discretion and without assigning any reason therefore refuse to register any proposed transfer of shares.
 - 9.1 In the event of such refusal the company shall pay to the transferee the fair value as determined hereof and the company as transfer agent shall transfer the shares to the remaining shareholders in the proportion of their holdings.

9.2 The company shall treat such payment as a dividend but shall not make any payment under this clause if there are reasonable grounds for believing that the company would after the payment be unable to pay its liabilities as they became due or the realizable value of the company's assets would, after that payment be less than the aggregate of its liabilities and the amount that would be required to be paid to shareholders on a redemption or winding up rateable with or before the holder of the shares to be transferred.


