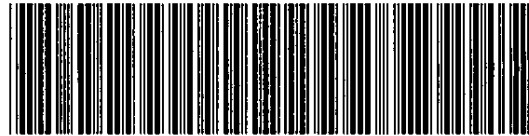

**FIRST:** The name of the corporation is: **Precision Turbines, Inc.**

**SECOND:** Its registered office in the State of Delaware is located at 16192 Coastal Highway, Lewes, DE 19958-9776, County of Sussex. The registered agent in charge thereof is *Harvard Business Services, Inc.*

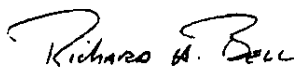
**EIGHTH:** The corporation reserves the right to amend or repeal any provision in this Certificate of Incorporation in the manner prescribed by the laws of Delaware.
