

We moved our small manufacturing company to Pasco County in June of 2006, but were unable to start doing business until October 10, 2006. We registered for our Occupational License with the County, and our Sales & Use Tax with the State at that time. I asked everyone I spoke to about what else we had to register for since we were new to Florida, but no one told me about registering the business with your office. I was told there wasn't anywhere to find out about all we had to do as a new company doing business in Florida. I sincerely apologize for the unintentional delay with the registration.
