

Elderhostel is a not-for-profit organization with more than 30 years of experience providing high-quality and affordable educational adventures primarily for older adults. Guided by the needs of older adults seeking new experiences and personal enrichment, Elderhostel is based on the belief that aging does not mean withdrawal from meaningful activity, and that the later years should be viewed as an opportunity to enjoy new challenges.

The Organization provides educational programs at over 2,300 educational and cultural sites throughout the United States, Canada and 90 other countries. 




