Dear Mr. Johnson:

The Department is in receipt of your request to allow SunTrust Bank to create one indirect subsidiary of the bank. SunTrust Bank currently owns 100% of SunTrust Leasing Corporation, a subsidiary engaged in personal property leasing and financing transactions. SunTrust Leasing proposes to create SunTrust Equipment Finance & Leasing Corporation (the "New Sub"). The New Sub will be a Virginia corporation which will be 100% owned by SunTrust Leasing and consequently an indirect wholly owned subsidiary of the Bank.

Your letter states that SunTrust Leasing intends to transfer its personal property leasing and financing portfolio into the New Sub in order to take advantage of state tax savings. Currently, it is anticipated that this portfolio will have a value of approximately \$6 billion.

The Department of Banking and Finance does not object to SunTrust Bank creating the one indirect subsidiary as outlined in the terms of your letter. If the detail of the transaction changes before the closing takes place, please notify this office. 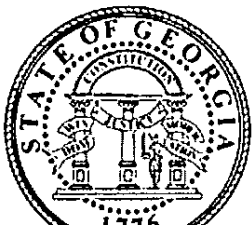
