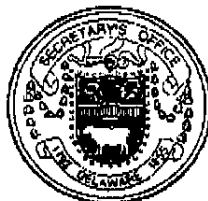



FIRST: That the Board of Directors of said corporation, by the unanimous written consent of its shareholder, filed with the minutes of the Board adopted a resolution proposing and declaring advisable the following amendment to the Certificate of Incorporation of said corporation:

RESOLVED, that the Certificate of Incorporation of PUM Agency Inc. be amended by changing the ARTICLE I thereof so that, as amended, said Article shall be and read as follows:

"The name of the corporation (the "Corporation") is: RenRe Insurance Underwriters Inc."

SECOND: That in lieu of a meeting, the stockholders have given unanimous written consent to said amendment in accordance with the provisions of Section 228 of the General Corporation Law of the State of Delaware.
