Dear Sir or Madam:

Enclosed please find an application by foreign corporation for authorization to transact business in the state of Florida for Stanley P. Walker, Attorney-at-Law, P.C. This professional corporation is incorporated in the State of Alabama, and I am its sole shareholder, director and president. I am duly licensed to practice law in both Alabama (admitted to Alabama Bar in 1996) and Florida (admitted to Florida Bar in 1998). I have practiced in the state of Alabama continuously since 1996; however, I did not begin practicing law in Florida until 2006. Regrettably (and embarrassingly), I failed to comply with F.S. 607.1501. To be quite honest with you, I overlooked the fact that as a corporation, my business would need to do an additional step in order to maintain an office in Florida and for me to practice law in Florida. I believe that if I were merely a sole practitioner in Florida, I would not have had to take this additional step, but since I incorporated in Alabama, then opened an out-of-state office for my corporation, I needed to obtain the certificate of authority first. Since I am the sole shareholder, director and president of my corporation, and the sole lawyer for the corporation, those roles can often overlap causing me to occasionally forget that I need to act corporately rather than individually.

As you can see from my application for authorization, I first began conducting business in Florida in July, 2006. For several years, I have been spending substantial amounts of personal time in the state of Florida (I would weekend vacation there). Also, a couple of years ago, I began to shift the nature of my practice from a general practice to immigration law. I ultimately concluded that since I already spent so much time in Florida, it would be worthwhile to open a branch office there to expand my growing immigration practice; this I did in the summer of 2006. Initially, the branch office was more of a hobby than a business idea in that I felt I should attempt to justify the personal time I spent in Florida. July, 2006 is when I actually first rented office space and began operating the branch office. However, I did not engage in the actual practice of law in the state of Florida through the branch office until August 25, 2006. This was the date I was hired by my first Florida client, and this client was my only one in Florida for all of 2006. As you can see from the enclosed copy of my Florida office receipt book, during the entire year of 2006, my corporation grossed \$1,120.00. As you can see, my corporation is small, and my failure to comply with F.S. 607.1501 was purely accidental and not intentional. Upon opening my office, I notified the Florida Bar, and I obtained a City License from the City of Panama City, Florida. I merely overlooked this additional step to register my foreign corporation with your office. I likely would not have realized I needed to

do this until my accountant pointed it out to me earlier this year - 2007 (it was he who originally suggested incorporation in Alabama in 2005 and I will certainly have to speak to him about the promptness of his future advice to clients who incorporate, and then decide to expand their business).

Pursuant to F.S. 607.1502, I understand that there is a penalty for failure to register for 2006 and 2007. Please let me know the amount of this penalty, since the statute references a range of \$500 to \$1,000 for each year, or part thereof. By my interpretation, that could be as low as \$1,000, or as high as \$2,000 for applying now, and I do not know if you have some sort of regulations or guidelines for determination of this penalty. Also, please let me know if there is any provision or application for a waiver or reduction of this penalty, given the innocent nature of this oversight. With regard to this request, please let me know if there is any additional information you may require or need for your consideration. Thank you in advance for your consideration of this request, and please do not hesitate to contact me if I can be of any further assistance.
