#### 1. Financial Assistance

Subject to subsection 43(2) of the Act and without any other restriction, the Corporation and any corporation with which it is affiliated may, in addition to any other powers it may have, give financial assistance, directly or indirectly, by any means including, without limiting the generality of the foregoing, by means of a loan or guarantee,

- to any shareholder, director, officer or employee of the Corporation, or of any affiliated corporation, or
- (b) to any associate of a shareholder, director, officer or employee of the Corporation or of an affiliated corporation.

#### 2. Meetings of Shareholders

2.1 Meetings of shareholders may be held within New Brunswick, or outside New Brunswick at any place where the Corporation has a place of business or any place where any shareholder resides or the majority of the shareholders decide to hold such meeting.

2.2 Notice of the time and place of a meeting of shareholders shall be sent not less than 5 days nor more than 50 days before the meeting to each shareholder entitled to vote at the meeting, to each director, and to the auditor, if any.

#### 3. Borrowing

3.1 The board of directors may, without authorization of the shareholders, from time to time, in such amounts and on such terms as they deem expedient:

- (a) borrow money upon the credit of the Corporation;
- (b) issue, reissue, sell or pledge debt obligations of the Corporation;
- (c) charge, mortgage, hypothecate, pledge or otherwise create a security interest in all or any currently owned or subsequently acquired, moveable or immoveable property of the Corporation, including book debts, rights, powers, franchises and undertakings, to secure any debt obligation or any money borrowed or other debt or liability of the Corporation; or
- (d) --give a guarantee on behall of the Corporation to secure performance of an obligation of any person.

3.2 The board of directors may from time to time delegate to such 1 person or more of the directors and officers of the Corporation as may be designated by the board, all or any of the powers conferred on the board in clause 3.1 above, to such extent and in such manner as the board shall determine at the time of each such delegation.

In accordance with 22 C.F.R. § 122.4, General Dynamics Corporation ("GD") hereby notifies the U.S. Department of State, Directorate of Defense Trade Controls ("DDTC") regarding the "statutory amalgamation" of its subsidiaries, General Dynamics Canada Ltd. ("GD Canada") with General Dynamics Land Systems - Canada Corporation ("GDLS-C"), and the changes to be reflected on GD's consolidated Manufacturer/Exporter and Broker Registration Statement.

On July 6, 2015, GD effected a statutory amalgamation of GD Canada with GDLS-C. The legal business name of the amalgamated entity is GDLS-C. Under the amalgamated entity, GDLS-C will continue to operate under the same legal and "doing business as" names. In contrast, the former GD Canada entity will become an operational division of the amalgamated entity (with its own management and reporting structure), and "doing business as" General Dynamics Mission Systems - Canada, a division of General Dynamics Land Systems - Canada Corporation.

<sup>1</sup> The term "statutory amalgamation," as used in this notification, is a Canadian legal combination of business entities into a single entity, similar to a merger, and effected through the operation of the New Brunswick Business Corporation Act. Unlike many mergers in the United States, a Canadian amalgamation does not result in the creation of a new legal entity, rather the combined entities operate separately under one legal entity.
