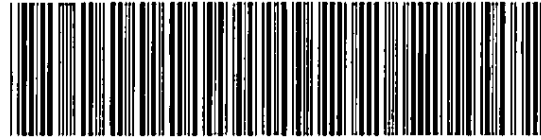

This firm serves as regulatory counsel to El Colegio de Ingenieros y Agrimensores de Puerto Rico (CIAPR). Our client is currently recognized as a non-profit in the territory of Puerto Rico and by the Federal Government. In 2008, CIAPR became registered in the State of Florida as a for-profit corporation, despite its non-profit status in the aforementioned jurisdictions. CIAPR wishes to change its status in Florida to reflect its recognition as a non-profit entity.

Pursuant to the information we received from the Secretary of State's Office, CIAPR must file a request to withdraw its authority as a foreign corporation to transact business or conduct affairs in Florida. Along with the withdrawal application, CIAPR must then refile as a Foreign Non-Profit Corporation.


