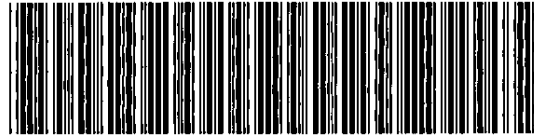


Please accept this letter as formal notification that I am resigning my position as Chief Financial Officer of Organa Technologies Group, Inc. effective today.
