Dear Ms. Golden:

My office represents COMDEVCO, Inc. in connection with the above referenced Application. I am in receipt of a copy of your March 5, 2008 letter to Keith Taylor, Jr., a copy of which is attached. In your letter, you indicate that a \$1,000.00 fine is due for failing to timely file/seek authority to transact business within the State of Florida, as well as UBR fee for 2007. This correspondence is in reply.

Although Comdevco, Inc. was incorporated in February 1981, contact with the state of Florida did not take place until July 1, 2007, and at that time only by virtue of acquiring a limited ten (10%) interest in a piece of real property located in Hillsborough County, Florida. The acquisition of this percentage ownership interest was for the purposes of estate planning. A copy of the Quit-Claim Deed vesting the ten percent interest in COMDEVCO is attached hereto.

At the time the transfer took place, the principals of COMDEVCO believed that COMDEVCO was exempt under F.S. 607.1501 (2)(m) from the requirements of obtaining a certificate of authority. Further, the statutory language of F.S. 607.1501(3) makes it clear that the exemption list is not "exhaustive", and COMDEVCO could have the reasonable belief that its minority ownership interest did not trigger the application requirements. The reason for filing at this time is in an abundance of caution, as COMDEVCO may be required to seek redress within the courts of the State of Florida in connection with the real property and its ownership interest.

Accordingly, COMDEVCO respectfully requests that the State review and reconsider the application filing and penalty fees in light of the foregoing. In the event the State determines that COMDEVCO's ownership interest in the real property does not constitute an allowable exemption under F.S. 607.1501(2), I would request that the State waive any penalty, as COMDEVCO could

reasonably believe that based upon the wording of the statute, the grounds for exemption from filing in this case do exist.

I look forward to hearing from you at your earliest convenience.
