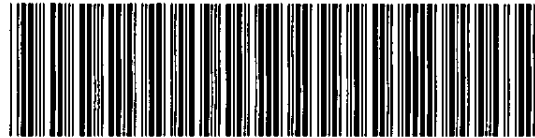

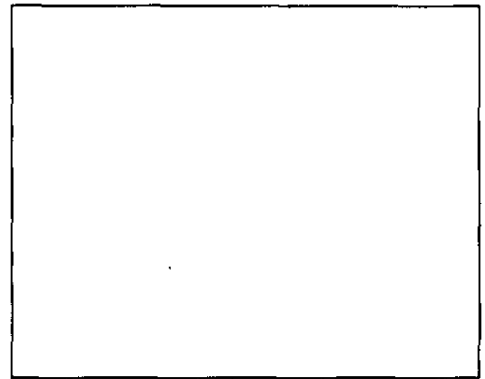

If I new this I would have done so immediately as was the case with unemployment sign up. I have had a UT number from the state of Florida since July 07.


I am the only employee of this company and cannot afford this type of penalty.
