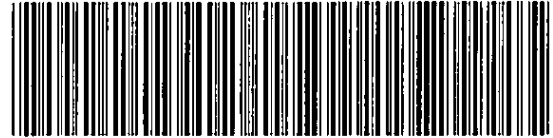

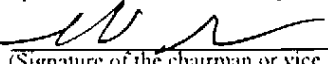

ARTICLES OF AMENDMENT
TO THE
AMENDED AND RESTATED
ARTICLES OF INCORPORATION

Pursuant to the provisions of the Nebraska Nonprofit Corporation Act, the undersigned Corporation hereby adopts the following Articles of Amendment to its Amended and Restated Articles of Incorporation:

FIRST: The name of the Corporation is OneChild Global, which, pursuant to the amendment below, was changed from Bethesda Ministries.

SECOND: The following amendment to the Amended and Restated Articles of Incorporation contained in the following resolution was adopted on September 7, 2022 by the Directors of the Corporation, to be effective as of October 1, 2022, in the manner prescribed by the Nebraska Nonprofit Corporation Act:

RESOLVED, that the first sentence of the Amended and Restated Articles of Incorporation of the Corporation which reads "The name of the Corporation is Bethesda Ministries." is hereby amended by revoking said sentence in its entirety and substituting the following provision therefor:

"Article I- NAME

The name of the Corporation is OneChild Global."

THIRD: Consent, in writing, to the foregoing amendment has been given by all of the directors of the Corporation.

FOURTH: Approval of the amendment was not required by any other person as the Corporation has no members, and the Amended and Restated Articles of Incorporation do not otherwise require a third-party approval for such matter.
